### Mandates

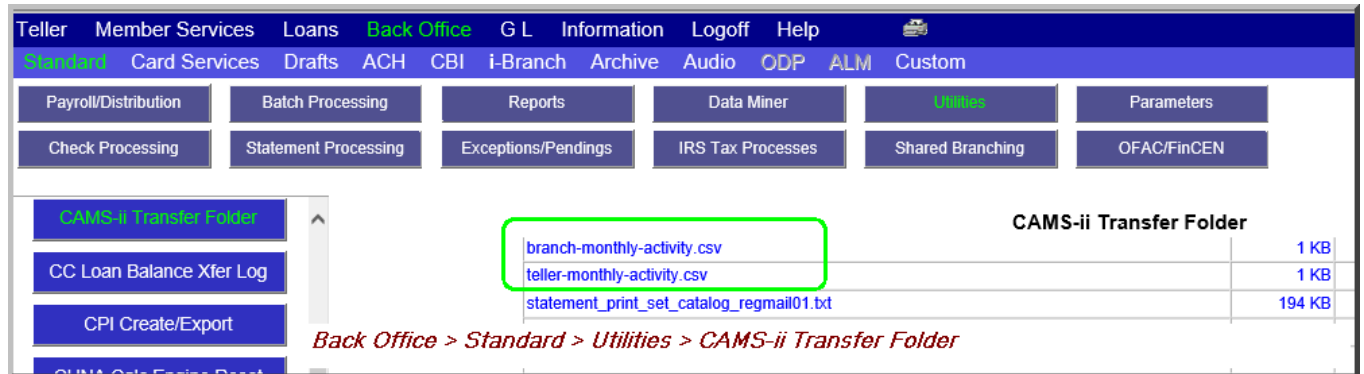
- Added the mandated Merchandise Returns function for Visa and Mastercard cards offered through Elan.

---

### Cash Drawer-Related Updates

- Cash Letters are now separated by the Branch location defined on the Terminal and then by the Teller ID.
- Portions of the Teller Transactions Summary By Month report—Teller Transactions Summary (`teller-monthly-activity.csv`) and Branch Transactions Summary (`branch-monthly-activity.csv`) are now available as a CSV file. You can access the files from the CAMS-ii Transfer folder

 Both .CSV files appear when the report is created via batch processing or on demand.



- With Cash Drawers selected for Denomination Tracking, you can no longer perform *Drawer Advances in from Nowhere*. You must perform *Drawer Advances Out first*. In these cases, if you access the Drawer Advance In screen without first performing the Drawer Advance Out a You have no pending advances warning message in red appears.
- With Cash Drawers NOT selected for Denomination Tracking, you must now perform a drawer advance *out* BEFORE a drawer advance *in*—if you choose *offsetting Teller Cash Drawers*.
- Added a new CAMS-ii System Property that allows a Teller type Cash Drawer to complete a drawer advance-out or advance-in *without selecting an offsetting cash drawer*.
  - If your credit union uses vault drawers and your credit union DOES NOT use Denomination Tracking, this property is set to N.
  - If your credit union DOES NOT use vault drawers and credit union DOES NOT use Denomination Tracking, this property is set to Y.
  - If your credit union uses vault drawers and your credit union uses Denomination Tracking, this property is set to N.

 **Contact CBS Support to change this setting.**

- Amounts that the tellers type into their balance screen without clicking **Store/Update** save as a "pre-balance" until you click **Make Available** in Cash Drawer Maintenance or until batch runs.
- Removed the **Clear** button from the Denomination pop-up for the Cash In and Cash Out quick offset transactions because it can cause a transaction to occur without logging the denominations.
- Added the ability to print branch address and phone number on member receipts for those credit unions with branches. The name of the Credit Union does not change. This is controlled by a user-accessible CAMS-ii System Property.

- If the **0 No Method Selected** Check Digit Calculation Method is set in Control-Drafts Parameters, the **-□** from the Account Inquiry Draft ID screen no longer appears.

### Bugs

The following items have been fixed.

#C2S00012996/#13191	TCRs/Pre-balance	<b>Fixed</b> A Pre-balance issue caused the TCRs not to update 100's in Denominations Tracking.
#C2S00013025	Shared Branching/Cash Denominations	<b>Fixed</b> When the first transaction of the day is a shared branching cash-in or cash-out, those denominations did not appear on the CAMS denomination count in the Teller Transaction Summary.
#C2S00013357	Draft Transaction History	<b>Fixed</b> The message, In Addition to Distribution no longer appears for every transaction for draft accounts.
#C2S00013375	G/L Transaction Detail	<b>Fixed</b> The Teller ID didn't appear correctly for manual G/L entries.
#C2S00013593	Balancing Display	<b>Fixed</b> In the Balancing > Detail Transactions screen, Drawer Advances In and Drawer Advances Out appeared as Drawer 0000 instead of the cash drawer where the advance originated.
